Materials Midwest Agg, Inc.-Locomotive Engine Placement);

Authorizing Acceptance of Locomotive Transfer

Deputy Fire Chief, Bill Murray, explained that Midwest Generation has offered the Fire Department a used but operable locomotive engine, which will be used for training purposes. The transfer of the locomotive will be at no cost to the Village but would require the Fire Department to remove it from Midwest Generation and place it on a portion of the Material Service quarry property.

RES23-3611 A Resolution Authorizing Waiving the Bids and Accepting a Purchase Agreement with MacQueen Equipment LLC

Deputy Chief Murray explained that one of our Fire Department Engines was struck by another vehicle while parked at a scene of an accident. The resulting damage was so extensive that the insurance adjuster determined that the engine was a total loss. The Fire Department Administration team found a fire apparatus that is ready to come off the line this August. Typical wait time on a new Fire Engine is around 2 years. The Fire Department is hoping to adjust the original cost listed in the resolution to account for an additional \$10,200 for an EMS cabinet to be installed inside of the new apparatus.

The Mayor commented that is was great than no one on our team was hurt during this incident and we hope the person who hit the engine makes a full recovery.

Trustee Richards asked how this new engine compares to the one we had and lost. Deputy Chief Murray said that we were lucky enough to obtain an engine that was very similar.
