4. PRESENTATIONS

25-3443 Presentation- Northern Will County Special Recreation Association (NWCSRA)

Director of Parks and Recreation, Kelly Rajzer, introduced the Executive Director of the Northern Will County Special Recreation Association, Jill Mukushina. Jill gave a brief overview of their programs and services and introduced their staff in attendance. Also in attendance are members of their basketball league sporting their medals they won from the tournament.

Mayor Noak commented that we are so fortunate to have this organization based in our community that serves so many areas.

Upon closing, the Village will convey the property onto the Forest Preserve District and they will contribute \$75,000 back to the Village for the acquisition cost.

Mayor Noak commented that we have had a great partnership with the Forest Preserve and their team. The Isle a la Cache is a gem in the community and this property will be an extension of that.
