1. CALL TO ORDER

3. PUBLIC COMMENT

Romeoville resident, Dwight Bendel, came to discuss snow. He expressed his concern about snow being plowed into handicap parking areas. He would like to know who is responsible for enforcement of the Ordinance on private lots, he would like clarification on this. Mr. Bendel also expressed his concern that the odd even parking is not being enforced, he sees cars that have not moved for weeks. He thinks that year around odd even parking might be a solution. Cars being left on the streets makes it harder for our Public Works Department to do their jobs, and they do a great job.

4. PRESENTATIONS

[ORD25-2031](#) **An Ordinance Amending Chapter 155 of the Village Code of Ordinances - Rental Property Inspections**

Village Attorney Rich Vogel requested that Ordinances 2031 and 2032 be combined for his presentation. He explained that both ordinances include updates related to rental inspections.

The first ordinance addresses rental property inspections and clarifies the distinction and definitions of tenants versus long-term or overnight guests.

The second ordinance outlines revisions to the inspection schedule for larger, professionally managed apartment complexes. To streamline the process for both inspection staff and property managers, these inspections will now occur every three years.

Village Attorney Rich Vogel explained that the Romeoville Gardens senior apartment complex is in the process of transitioning from a tax credit supported, below market rate housing product to a market rate housing

product. The tax credits have expired after 30 years, and the property now needs to refinance. As part of this process, the Village will release a fourth mortgage and require that funds be placed in escrow to ensure completion of necessary parking lot maintenance.

The Mayor noted that the original program has expired and the Village has no authority to prevent this transition.

Village Manager Dawn Caldwell provided a combined explanation of RES25-4144 and RES25-4145. She noted that the Village has been using the same software for finance, utility billing, human resources, and payroll for approximately 20 years, and that the current system will no longer be supported. In response, staff issued Requests for Proposals and assembled a committee to review the submissions. This evaluation process has taken place over the past two years. Staff is recommending UKG for payroll services and BS&A for the Village's Enterprise Resource Planning software.
