## **Project Information**

Project Name: Site Relocation of Independence Boulevard Pressure Reducing Valve (PRV) Station

Project Description: As outlined in OWNER's Water System Master Plan, the Independence Boulevard PRV station is one of the water distribution system modifications needed to merge the Marquette Zone north of this PRV station into the Windham Zone and the Marquette Zone south of this PRV station into the South Zone, thus eliminating the Marquette Zone. Task Order No. 19-01 included design and preparation of Bidding Documents for this station. The site has moved approximately 425 feet southwest along Illinois Route 53.

Services Description: Provide design services to revise the Bidding Documents to reflect the new site.

## Scope of Services

ENGINEER will provide the following services to OWNER:

- 1. Assist OWNER with procurement of topographic survey and plat of survey services to include OWNER's property along Independence Boulevard, temporary easement, and adjacent right-of-way.
- 2. Assist OWNER with procurement of geotechnical engineering services for this project.
- 3. Revise PRV station final design drawings and technical specifications to reflect the new site layout, including site piping and new electrical service connections. Existing access drive from Illinois Route 53 will be used for site access.
- 4. Prepare one set of Bidding Documents using Engineers Joint Contract Documents Committee C-700 Standard General Conditions of the Construction Contract, 2018 Edition, technical specifications, and engineering drawings.
- 5. Submit Bidding Documents to OWNER for review and input.
- 6. Prepare an updated opinion of probable construction cost for the project and submit to OWNER.
- 7. Submit updated Bidding Documents to and request a revised Public Water Supply Construction Permit from the Illinois Environmental Protection Agency for approval.
- 8. Submit Bidding Documents, Traffic Control Authorization Request, and Region One Utility Permit to the Illinois Department of Transportation for approval.
