1. CALL TO ORDER

4. PRESENTATIONS

ORD25-1980 An Ordinance Amending Village Code of Ordinance Sections 136.01 Through 136.09, Adding Sections 136.01A, 136.02A to E, 136.03A and Combining Sections 136.03 & 136.04 and 136.06 & 136.07

> Village Attorney, Rich Vogel, explained that this ordinance makes a few housekeeping changes to the village code book which brings the code into compliance with current State law regarding cannabis use, possession, and paraphernalia, among other cannabis regulations.

RES25-3997

A Resolution Approving a Water Main, Storm Sewer and Sanitary **Sewer Utility Operation and Maintenance Agreement**

Mr. Vogel explained that this agreement places maintenance responsibilities on the developer and successors at Highpoint Town Square regarding the maintenance and operation of water main, storm sewer and sanitary sewer improvements.

No questions or comments were raised by the board.

RES25-3998

A Resolution Authorizing a Development Agreement with Romeo **Town Center Holdings LLC**

Mr. Vogel discussed the plans for incentives regarding the development of Romeo Town Center located at Weber and 135th Street. These include \$500,000 towards the cost of constructing a traffic signal. Improvement plans include parking lot resurfacing, painting of the rear building facade, and signage and landscaping improvements. To continue to support the redevelopment of the site, the Village is also providing for additional incentives up to \$200,000 towards the development of each of the two

outlots or \$400,000 towards an entirely new building.

Mayor Noak commented that this is more of a signalized entrance which has been discussed. This was approved many years ago by the county as the road is under the county jurisdiction. There is a lot of activity going on and all of that is predicated on moving forward with the items discussed.

ORD25-1974 An Ordinance Approving an Amendment to a Special Use Permit for a Planned Unit Development - Final Development Plan for Anabi Oil Corporation (Rebel Convenience Stores) at 1300 W. Normantown Rd

> Community Development Director, Josh Potter, explained that Anabi Oil has applied for a parking lot reconfiguration, landscaping, and new signage for their existing gas station located at 1300 Normantown Road. A new drive thru is proposed for the south end of the convenience store to allow for the new Hatch Chicken concept. An outdoor seating area with landscaping is proposed between the extended parking rows and the drive thru. New signage to reflect the new branding and accessory usages will be installed. Included in the renovations is a 200-square foot area in the northeastern section of the building which will be converted to accommodate six video game terminals. This use does require exceptions from the section of the code governing licensed truck stops.

Development Review Committee has reviewed the proposal and the Planning and Zoning Commission held a public hearing on April 8, 2025 and recommends approval.

Mayor Noak commented that this is a legacy site and they are reinvesting to maintain their business and prosper. We are excited they are bringing a new restaurant. This intersection continues to evolve.

Daniel Vater from the Anabi Oil team commented that this site has been a staple to the community for many years and this site is planned to have a more vibrant feel to maintain good business.

Mayor Noak thanked the team for their reinvestment in the community.

ORD25-1972 An Ordinance Amending Chapter 112 (Alcoholic Beverages) of the Village of Romeoville Code of Ordinances (Gaming Endorsement for Rebel)

> Mr. Vogel explained that Mr. Potter just discussed a considerable amount of improvements and work that is being done on the Rebel site and this ordinance allows for the continued support of the business by approving the gaming endorsement which will provide additional revenue to support the investment they are making.

Mayor Noak commented that this is because of the unique nature of the site and that it meets the State criteria for gaming.

Mr. Vogel commented that this is not a pattern that we expect to see else where in the Village.

ORD25-1979 An Ordinance Amending Chapter 159 (Zoning Ordinance) of the Village of Romeoville Code of Ordinances

Mr. Potter shared that staff is proposing updated zoning codes. These updates include fences, cannabis, accessory structures, and signage. Development Review Committee has reviewed the proposal and recommends approval and the Planning and Zoning Commission held a Public Hearing on April 8th, 2025 and they also recommend approval.

Trustee Richards commented that Planning and Zoning asked a lot of questions and ultimately recommended approval. The key to this is that most are State law updates.

Mayor Noak commented that these are functional as we evolve and see how things are working.
