

Notes:

- 1) *Weed control methods shall be chemical or mechanical and based on best practices for each particular weed species.*
- 2) *Controlled burning shall be conducted during spring or fall windows and within the parameters of each site's controlled burn prescription. V3 will notify adjacent property owners with an advance notice letter via USPS. The client shall be notified the day before and on the morning of any controlled burns.*
- 3) *Items 5.02, 5.03, 7.01, & 7.02: V3 shall provide spot treatment and dead material mowing of Common Reed within the Boucher Preserve (wetland) and Lily Cache Greenway (slough). The total acres listed (20 acres & 21 acres) represent an estimate of the total site amounts of Common Reed growing within these properties. Adjustments may need to take place based on actual site needs. If Common Reed populations are under these amounts, V3 will focus on other invasive species to fulfill the acreage amounts within this proposal.*
- 4) *Item 11.02: V3 will design and install 100 2" plugs or a lesser amount of larger container plants. This is to be determined based on site conditions and nursery availability.*
- 5) *Item 13.01: Weed control efforts are for Common Reed only.*
- 6) *Item 14.01: Control Burn limits will be directed based on needs determined by V3 and The Conservation Foundation.*
- 7) *This proposal is the original contract and constitutes the entire agreement between the purchaser and V3 Construction, Ltd.*
- 8) *Item 6.02: V3 shall purchase and sow turf grass in bare spots along the walking path around the NE basin (Basin B). Seed will be sown in the fall of 2025 or spring of 2026.*
Item 6.04: V3 shall design, purchase, and sow a native seed mix for the NE basin (Basin B). Seed will be sown after the controlled burn.
- 9) *This is considered a lump sum project and unit prices listed are for reference.*

The Following is specifically excluded from this estimate:

- 1) *Bonds, permits (outside of IEPA and local prescribed burning), warranties, retainers, and special insurance (waiver of subrogation, pollution liability insurance).*
- 2) *Goose prevention fencing.*
- 3) *Aquatic weed control.*
- 4) *Woody control, unless specified.*
