Furnish and install (4) 20' x 16' CHI model 3285 white polystyrene insulated (R-value = 10.29) micro-grooved sandwich steel doors with (5) 24" x 6" windows in the 3rd section and (4) Liftmaster model TDC12S1BMC MAXUM (3/4HP equivalent, 120v) commercial duty trolley operators complete with 16' rails. The doors will include standard 15" radius 3" full angle track, 100,000 cycle torsion springs, 11ga hardware, and vinyl perimeter weatherseal. Each operator will include (1) surface mounted floor level wall controller and (1) set of photo eyes.

TOTAL COST: \$68,750.00
