John D. Noak, the President of the Board of Trustees of the Village of Romeoville, Will County, Illinois (the "Village"), called the meeting to order as the individual appointed by the Village Board of Trustees, on behalf of the Village, to conduct such public hearing.

John D. Noak presented a copy of the publisher's affidavit, with a newspaper clipping attached, showing the publication on May 25, 2021 of the notice of the public hearing in the *Chicago Tribune*, a newspaper of general circulation in the Village, which affidavit is on file in the office of the Village as part of the permanent record of the Village.

John D. Noak stated that the purpose of the meeting was to conduct a public hearing, pursuant to published notice as required by law, on the proposed issuance by the City of Aurora, Kane, DuPage, Will and Kendall Counties, Illinois (the "Issuer") of its Revenue Bonds Series 2021 (VNA Health Care), in one or more series, in an aggregate principal amount not to exceed \$15,000,000 (the "Bonds"), the proceeds of which will be loaned to VNA Health Care, an Illinois not for profit corporation, for the purposes described in said notice.

John D. Noak then announced that all those interested persons wishing to contend for or protest against the issuance by the Issuer of the Bonds for such purposes, orally or in writing, would be heard and that all such written or oral statements would be considered.
