Ms. Rajzer requested to discuss both RES24-3803 and RES24-3804 together. Ms. Rajzer explained that two bids were received for Romeo Crossing Park Phase III and would like to have approval to accept the lowest qualified bidder, George's Landscaping. Within the scope of the

project, multiple amenities will also be purchased and included in this phase. It was also noted that once this project is completed, we will received \$300,000 from NWCSRA and for the next 10 consecutive years we will receive \$30,000 for this park. This park was also partially funded by an OSLAD grant.

Fire Chief, Kent Adams, explained that the Fire Academy has a unique opportunity to purchase a trailer fully equipped with rescue equipment from Paratech. The Academy in the past has been able to use this trailer that Paratech demos, but the company is no longer offering demo trailers. The equipment on the trailer is estimated at more than \$80,000, not including the cost of the trailer, and Paratech is offering the trailer and equipment for around \$28,000.
