RES23-3703 A Resolution Approving the Commitment of Local Matching Funds for Roadway Projects Eligible for STP Grants

Sponsors: Chris Drey

Chris Drey, Public Works Director, explained that the Village will be submitting five projects to the Will County Governmental League for consideration of STP grant funding. The total amount of the local match for the five projects is \$1,852,330. The remaining 80% of the projects costs would be federally funded through the grant.
