Thank you for allowing Express Signs & Lighting Maintenance, Inc. the opportunity to present a quotation for your electronic signage program for the Park District located at 900 W Romeo Road.

DESCRIPTION: Express Signs & Lighting Maintenance, Inc. will:

- Remove the existing marquee sign at 900 W Romeo Road.
- Retro fit into the existing sign (1) 60 x 150 matrix 15.85 mm full color double faced Daktronics message center. The message center will be capable of displaying up to 8 lines of 4" character type with a maximum of 30 characters per line with animation, time and temperature functions, pictorial scrolling and other special effects. The message center will have a viewable area of 3'2" x 7'10" and will be in a 3'8" x 8'1" sign cabinet. Communication with the sign will be by wireless ethernet bridge radios.
- Manufacture and install (1) 1'4" x 8'1" ID sign cabinet that will be internally illuminated by white LEDs with white lexan faces that will have translucent blue vinyl with the copy removed. **COPY TO READ:** Village of Romeoville Where Community Matters

COST..... \$26,939.00

TAXES: Please supply tax exempt number.

TERMS: A deposit of one half the total purchase price (\$13,469.00) shall be submitted with this order, the balance being due upon completion. A finance charge of 1.5% per month (18% annually) will be charged on all past due accounts over thirty (30) days.

ELECTRICAL: All electrical feeds are the responsibility of the customer and are to be located at the sign base.

WARRANTY: A full (1) one year warranty is included with this contract. The electronics has a (4) four year warrant from Daktronics.

WARRANTY: There is a (1) one year warranty on all parts and labor, after the one year warranty is up on parts and labor there is an additional (4) four year warranty on LED's and power supplies.

REMEDIES FOR DEFAULT: In the event that the customer fails to pay for all services, labor and material, provided for herein, pursuant to the payment terms and conditions as set forth herein, then Express Signs and Lighting Maintenance, Inc. shall have any and all remedies provided by the statutes and the Common Law of the State of Illinois and, shall in addition to those remedies have the right to recover all reasonable attorneys fees for the collection of any delinquent sums due hereunder including reasonable collection costs and any law suit; legal for expenses for the cost of preparing, filing and recording any mechanics liens and any and all reasonable attorneys

fees incurred in the filing of any mechanics liens resulting from customers failure to pay or other default pursuant to the terms and conditions of these agreements.


