Please find following the proposal regarding the above-mentioned project. The bid price includes all appropriate insurance premiums, union benefits, licenses, and cleanup. Cost allocation for appropriated hook up for a 220 three phase electrical volt source, liquidated damages, dust protection, sealant, waterproofing, dampproofing, protection of existing pavement or landscaping, waiver of subrogation, builders risk insurance, wage escalation, coloring or staining of masonry units, masonry demolition, anchor bolts, copper expansion joints purchase, pollution insurance, mechanical expansion or control joint, doweling of rebar into concrete, water availability, winter protection, welding, miscellaneous steel and/or cast lintels are not included. The work being addressed is as follows:

Masonry construction and scope as delineated by Architectural & Structural drawings from Wight & Company, Darien, IL dated 7-15-19.

The scope of the base masonry work as delineated above comes to the sum of \$77,775.00. All debris will be removed by Cyberdyne to dumpsters provided by Cyberdyne.

- 4. Costs affiliated with Section 01340 and the drafting of any shop drawings if required along with possible PE Stamp or certified engineering.
- 5. Costs associated with reviewing drawings or patching of other trades. (mechanical, electrical etc.)
- 6. Costs associated with installation of Graffiti Coating.
- 7. Costs associated with MBE/WBE requirements
- 8. Costs associated with Air/Vapor Barrier.
- 9. Costs associated with any type of Wall stabilization at TOW.
- 10. Costs associated with any type of winter protection.
- 11. Costs associated with pigmented mortar.
- 12. Costs associated with any type of injected foam for insulation.
- 13. Costs associated with any type of shoring of existing conditions.
