AMENDMENT TO LICENSE AGREEMENT DATED AS OF DECEMBER 5, 2018 BETWEEN THE VILLAGE OF ROMEOVILLE AND 3 PHASE LINE CONSTRUCTION, INC.

This Amendment (the "Amendment"), is made and entered into this _____ day of _____, 2020, A.D., by and between the Village of Romeoville ("Village") and 3 Phase Line Construction, Inc. ("Licensee")

2. <u>Amendment of Agreement</u>. That the references to the date December 5, 2019 in Sections 2 and 3 of the Agreement are hereby amended to refer to the date June 30, 2020, in each of said Sections 2 and 3 of the Agreement.

3. <u>Effect of Amendment</u>. The terms and provisions of this Amendment shall supersede and control over any expressly conflicting terms, conditions or provisions of the Agreement, but all other terms, conditions and provisions of the Agreement are currently and shall remain in full force and effect, and the same shall not in any way be

altered, affected, modified, limited or construed by the terms, conditions and provisions of this Amendment. Any term used and defined in the Agreement and also used or referred to in this Amendment shall have the same meaning in this Amendment as set forth therefor in the Agreement. This Amendment and the Agreement, taken together, set forth all the promises, inducements, agreements, conditions and understandings between the Village and the Licensee concerning the subject matter thereof, and there are no promises, agreements, conditions or understandings, either oral or written, express or implied, between them, other than are set forth therein. Except as herein otherwise provided, no other or subsequent alteration, amendment, change or addition to the Agreement shall be binding upon the parties hereto unless authorized in accordance with law and reduced in writing and signed by them.
