### **An Ordinance for the Levying and Collection of Taxes for the Village of Romeoville, Will County, Illinois, for the Fiscal Year Commencing the First Day of May, 2019 and Ending the 30th Day of April 2020.**

The next two items will be presented together. Mayor Noak stated that as always the Village sets the levy high as we work on a May to May budget and this allows us to make adjustments prior to the passing of the final budget. We have been doing this for a number of years. We are just getting through mid-year of the previous budget.

Mr Openchowski stated that we will have a public hearing during the regular meeting. The levy will be very close to what it was the prior year. Based on information from the County our EAV will increase approximately 3.63%.

Also, on the consent agenda there are 8 ordinances to abate the bond payments to remove them from the property tax rolls as there are other revenue streams to pay for these payments.
