5. MAYOR'S REPORT

Chief Kroll spoke on the recent tragedy at the Highland Park Fourth of July Parade. Our thoughts and prayers go out to the friends, families, victims, and the entire Highland Park community. The Romeoville Police Department hopes that a tragedy like this will never happen, but are fully trained for moments of chaos. This past spring, Romeoville was a site of a massive training exercise for FEMA and many organizations in Will County. Last month, officers took part in an active shooter training at a local middle school along with our Fire Department. Recently, the RPD has been taking advantage of vacant village owned properties off Route 53 to practice dynamic entry and room clearing. Bolingbrook PD called two weeks ago

looking for assistance with an active shooter and every on duty RPD officer went to help. Our July 3rd fireworks brought big crowds and RPD did not receive any calls that day.

The Mayor sent his thoughts and prayers to everyone impacted in Highland Park. It is good to know that we have very dedicated people who work for us and keep us safe.

The July 3rd fireworks were amazing! We had a great turn out and it was well coordinated. Condolences to the Braasch family on the passing of Robert who worked for the Village for many years. There was a ribbon cutting for JBam Epic Designs, a tour hosted by Will County CED, Park Party at Pine Trail park, and the ribbon cutting for Pinnacle Drive. It will take some time for the new traffic pattern to occur. Pinnacle Drive now extends from Airport Road to Renwick to allow for truck and shift change traffic to ease. Opportunity Matters held a workshop that was really well attended. Be safe this summer and be conscience of our neighbors.

8. VILLAGE MANAGER'S REPORT

The Village has contracted with Mallon and Associated to conduct a market analysis for another grocery store within Romeoville. That first step was completed in June. The study focused on market potential for both the Weber Road and Route 53 corridors and they analyzed foot traffic, customer characteristics, demographics, and current competition. The findings were positive and they are now in the implementation stage and will be contacting 35 grocers on our behalf to determine their interest. The Village is offering a financial incentive grant program in an effort to attract and increase new dining, shopping, and entertainment opportunities in Romeoville. We are proposing to cancel the next two meetings to have one meeting in July and one meeting in August.

The Mayor commented that the grocer is an ongoing process and a complex one. It requires a very in depth analysis.
