- **Section 1:** That the above recitals and referenced reports are hereby incorporated and made a part of this Ordinance:
- Section 2: That approval of the Planned Unit Development Final Development Plan is hereby granted by the Village, in which the Village President is hereby authorized to sign, and the Village Clerk attest thereto, that the said Final Development Plan has met all of the requirements as herewith attached and is authorized to proceed at the site legally described as follows:

LOT 3 IN ROMEOVILLE INDUSTRIAL PARK, UNIT ONE, BEING A SUBDIVISION OF PART OF THE NORTHEAST QUARTER OF SECTION 34, TOWNSHIP 37 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPLE MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED SEPTEMBER 18, 1986 AS DOCUMENT NO. R86-42585, IN WILL COUNTY, ILLINOIS.

- Section 5: The approvals set forth in this ordinance and any of the submittals approved thereby shall be subject to such revision as may be deemed necessary by the Village of Romeoville to reasonably accommodate the substance of any resolution of the pending cross-access dispute between the applicant/owner and the adjacent property owner.
