**A Resolution Authorizing an amendment to the existing agreement in order to extend the estimated ending date for the Phase I Engineering for I-55 Interchanges at Illinois Route 126 and Airport Road (Job P-91-130-07)**

WHEREAS, it is necessary to revise the estimated ending date for completion of Job P-91-130-07 and thereby the obligation end date; and,

WHEREAS, it is mutually agreed the revised ending date of Obligation AL 07327 be extended to December, 31, 2018 making the term of this agreement May 30, 2007 to December 31, 2018; and,

WHEREAS, all remaining provisions of the original agreement and/or prior amendments are not altered by this amendment.

**NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROMEOVILLE, WILL COUNTY, ILLINOIS:**

**SECTION ONE.** The foregoing Recitals are hereby incorporated into this resolution as if fully set forth in this Section 1.

**SECTION TWO.** That the Village President is hereby authorized and directed to execute this Amendment Agreement to extend the State Obligation end date.

**SECTION THREE.** That the Village President is hereby authorized and directed to execute the Affidavit to Extend/Local Agency document which is required to avoid repayment of all Federal-aid reimbursements.

**SECTION FOUR.** This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
