## RESOLUTION

**A Resolution authorizing the waiving of bids to purchase 6 MSA G1 Self Contained Breathing Apparatus, 58 air cylinders, and other necessary SCBA accessories, from Air One Equipment, Inc., South Elgin, Illinois a distributor of MSA Products, in the amount of \$79,990.00**

**Whereas**, pursuant to the provision of 65 ILCS 5/8-9-1 and the provisions of Village Ordinance No. 2793-00 the Village of Romeoville may by a vote of 2/3 of its Trustees then holding office, waive the requirements for public bidding on Village fire department equipment; and;

**Whereas**, in connection with the fire department purchase of 6 MSA G1 Self Contained Breathing Apparatus, 58 air cylinders, and other necessary SCBA accessories from Air One Equipment, Inc., South Elgin, Illinois

**Whereas**, upon review by Village staff it was concluded that to assure compatibility and standardization of breathing equipment, MSA/Air One Inc., is the sole provider for this equipment. Therefore, it is the fire department's recommendation that the Village enter into a contract to purchase this equipment in the amount of \$79,900.00

**NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES FOR THE VILLAGE OF ROMEOVILLE, WILL COUNTY, ILLINOIS, AS FOLLOWS:**

**Section 1:** The Village of Romeoville approves the waive of public bid and purchase from Air One Equipment, Inc., for the SCBA's and necessary accessories

**Section 2:** The Resolution shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by law.
