## A Resolution Waiving the Formal Bidding Process and Awarding Ditch Grading and Native Plantings Restoration at the JJC Soccer Practice Fields Project to V3 Construction Group, Ltd. in the Amount of \$56,000.

**Whereas,** The Village of Romeoville ("The Village") is a municipality in accordance with the Constitution of the State of Illinois of 1970; and,

**Whereas**, pursuant to the provisions of 65 ILCS 5/8-9-1 and the provisions of the Village Ordinance No. 2793-00, the Village of Romeoville may vote by 2/3 of its Trustees then holding office to waive the requirements for public bidding on Village public work, or improvement projects; and,

Whereas, Village Staff received proposals from a qualified contractor that is currently performing similar work throughout the Village to perform construction related services for the JJC Soccer Practice Fields; and,

Whereas, the Village of Romeoville has used V3 for the management of the Village's open spaces for several years and has been satisfied with their performance to-date; and,

Whereas, the expenditures for these improvements are allocated in the Fiscal Year 2017/2018 Budget; and,

Whereas, Village Staff has reviewed the proposals and recommends the Village Board award the contract to V3 Construction Group, Ltd. in the Amount of \$56,000;

## NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES FOR THE VILLAGE OF ROMEOVILLE, WILL COUNTY, ILLINOIS, AS FOLLOWS:

- Section 1: <u>Incorporation of Recitals</u>: The foregoing recitals are hereby incorporated into this Resolution as if fully set forth herein.
- Section 2: <u>Waiver of Public Bid Requirements</u>: Pursuant to the provisions of 65 ILCS 5/8-9-1 and the provisions of the Village Ordinance No. 2793-00 the Village hereby waives the public bidding

requirements otherwise applicable to this project.

- Section 3: <u>Repealer</u>: All other Ordinances or parts of ordinances of the Village of Romeoville that are inconsistent with this ordinance are hereby expressly repealed.
- Section 4: <u>Severability</u>: In the event any word, phrase, clause, sentence, paragraph, provision, or section of this Resolution or any portion thereof shall be held to be unconstitutional, unenforceable, or void, the same shall not affect the validity or enforceability of any remaining words, phrases, clauses, sentences, paragraphs, or sections thereof.
- Section 5: <u>Effective Date:</u> The resolution shall take effect after its passage, approval, and publication in pamphlet form, as provided by law.
