An Ordinance Amending Chapter 74.12(E) (Parking) of the Village Code of Ordinances

WHEREAS, the Village of Romeoville has heretofore adopted certain ordinances now codified as and for Chapter 74 pertaining to the regulation of parking within the Village on Village streets and property; and

WHEREAS, after Village staff review, it has been determined that amendments to Chapter 74 are required to facilitate parking permit enforcement measures for the Romeoville Metra Station Parking Lot.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES FOR THE VILLAGE OF ROMEOVILLE, WILL COUNTY, ILLINOIS, THAT:

SECTION 1: RECITALS. The foregoing recitals are hereby incorporated into this Ordinance as if fully set forth herein.

<u>SECTION 2:</u> AMENDMENT OF CHAPTER 74.12(E) OF VILLAGE CODE OF ORDINANCES. Chapter 74 .12(E) of the Village Code of Ordinances shall hereby be amended to reads as hereinafter set forth.

74.12 (E) Notwithstanding subsection (D) above, a first citation issued for no valid permit shall be a warning, a citation issued after the warning for no valid permit at the Romeoville Metra Station shall carry a fine in the amount of \$100.00, and thereafter all subsequent citations therefor shall carry a fine in the amount of \$200.00.

<u>SECTION 3:</u> SEVERABILITY. That the various provisions of this Ordinance are to be considered severable and if any part or portion of this Ordinance shall be held invalid by any Court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance.

<u>SECTION 4:</u> CONFLICTS. All prior Ordinances and Resolutions, or parts thereof in conflict or inconsistent with this Ordinance are hereby expressly repealed only to the extent of such conflict or inconsistency, and upon such repeal the relevant substantive provisions thereof shall be deemed to be replaced with the relevant substantive provisions hereof.

SECTION 5: EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its approval and publication in pamphlet form as provided by law.
