A Resolution Waiving the Public Bidding Process and Authorizing the Purchase of Bullet Resistant Glass Window Panes

Whereas, pursuant to a two-thirds vote of the Village Board of Trustees, the Board may waive the requirements of the Village Code of Ordinances and the Illinois Municipal Code to competitively bid certain contracts for the procurement of goods and services or performance of certain work; and

Whereas, the Village of Romeoville desires to enter into that certain agreement for the purchase of bullet resistant glass window panes; and

Whereas, the Police Department will be using \$25,000.00 from approved 18-19 budget funds for the purchase and install of bullet resistant glass window panes for some of the police department south facing first floor windows; and

Whereas, Alliance Glazing Technologies is the local vendor and installer for bullet resistant glass manufactured by Patriot Armor with the features required by the police department.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ROMEOVILLE, WILL COUNTY, ILLINOIS:

SECTION ONE. The forgoing Recitals are hereby incorporated into this resolution as if fully set forth in this Section 1.

SECTION TWO. The competitive bidding process of the Village of Romeoville Code of Ordinances and the Illinois Municipal Code is hereby waived, and staff of the Village are hereby authorized and directed to execute an agreement with Alliance Glazing Technologies for the purchase and install of bulletproof glass window panes for some of the police department south facing first floor windows in the amount not to exceed \$25,000.00.
