An Ordinance Declaring Certain Playground Equipment as Surplus Property and Authorizing the Execution of a Playground Equipment Donation Agreement and Rider thereto with Kids Around the World, Inc., an Illinois not for profit corporation

WHEREAS, pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 11-76-4) the corporate authorities of the Village of Romeoville (the "Village") are authorized to sell, donate, or otherwise dispose of surplus personal property when, in the opinion of a majority of the corporate authorities, the continued ownership of such personal property by the Village is no longer necessary or useful to or in the best interests of the Village; and

WHEREAS, the corporate authorities of the Village have determined that the continued ownership by the Village of certain playground equipment removed or to be removed from Budler Park and identified more specifically in Exhibit A hereto is no longer necessary or useful to, nor in the best interest of the Village of Romeoville, and authorize and direct the disposition thereof in accordance with the terms of a Playground Equipment Donation Agreement and Rider thereto with Kids Around the World, Inc., an Illinois not for profit corporation, a copy of which is attached hereto and incorporated as Exhibit B.

NOW, THEREFORE, be it ordained by the President and Board of Trustees for the Village of Romeoville, Will County, Illinois, the following:

<u>SECTION 1</u>: RECITALS. The foregoing recitals are hereby incorporated into this Ordinance as if fully set forth herein.

<u>SECTION 2</u>: DECLARATION AS SURPLUS; AUTHORIZATION OF DISPOSITION. The playground equipment removed or to be removed from Budler Park and identified in Exhibit A are hereby declared to be surplus, and the continued ownership thereof is determined to no longer be

necessary or useful to or otherwise in the best interests of the Village, and the proper personnel of the Recreation Department are hereby authorized to dispose of the same in accordance with the terms of a Playground Equipment Donation Agreement and Rider thereto with Kids Around the World, Inc., an Illinois not for profit corporation, a copy of which is attached hereto and incorporated as Exhibit B.

<u>SECTION 3</u>: SEVERABILITY. That the various provisions of this Ordinance are to be considered severable and if any part or portion of this Ordinance shall be held invalid by any Court of contempt jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance.

<u>SECTION 4</u>: CONFLICTS. All prior Ordinances and Resolutions, or parts thereof in conflict or inconsistent with this Ordinance are hereby expressly repealed only to the extent of such conflict or inconsistency.

<u>SECTION 5</u>: EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
