# An Ordinance Approving The Annexation of Territory U-Haul at 681 S. Weber Road

**WHEREAS**, The Village of Romeoville (The Village) and Amerco Real Estate are entering into an agreement to annex a tract of land at the northeast corner of Weber Road and Gaskin Drive; and,

WHEREAS, a petition for annexation has been filed with the Village and is attached as Exhibit A; and,

WHEREAS, the parcel, consisting of 3.3 acres, is shown on the Plat of Annexation attached as Exhibit B; and,

**WHEREAS**, said request for Annexation has met all of the procedural requirements of the Village of Romeoville, Village Board of Trustees, Planning & Zoning Commission, Development Review Committee, and the Code of Ordinances, as amended; and,
