A RESOLUTION WAIVING PUBLIC BIDDING REQUIREMENTS

WHEREAS, pursuant to the provision of 65 ILCS 5/8-9-1 and the provisions of Village Ordinance No. 2793-00 the Village of Romeoville may by a vote of 2/3 of its Trustees then holding office, waive the requirements for public bidding on Village fire department equipment; and

WHEREAS, in connection with the fire department purchase of 26 sets of Morning Pride - Honeywell Rescue Coats and Pants from MES - Municipal Emergency Services, Deer Creek, Illinois.

WHEREAS, upon review by Village staff it was concluded that MES is the sole provider of Morning Pride Rescue Coats and Pants in the Chicagoland area. Therefore, it is the fire department's recommendation that the Village enter into an agreement to purchase this equipment in the amount of \$58,786.00

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND MEMBERS OF THE BOARD OF TRUSTEES OF THE VILLAGE OF ROMEOVILLE, WILL COUNTY, ILLINOIS that:

Section 2: <u>Waiver of Public Bid Requirements</u>: Pursuant to the provisions of 65 ILCS

5/8-9-1 and the provisions of the Village Ordinance No. 2793-00 the Village hereby waives the public bidding requirements otherwise applicable to the

contract for the purchase of new equipment for the fire department.
