# A Resolution Approving a Plat of Easement Troutman and Dams

**WHEREAS**, Troutman and Dams, the developer of the northwest corner of IL Route 53 and Romeo Road that includes Thorntons, Romeoville Express Car Wash, Joe's Beverage Warehouse and two remaining lots, has submitted a plat of easement for the development, and has requested the approval of a Final Plat of Easement attached as Exhibit A and prepared by Compass Surveying; and,
