A Resolution Approving a Final Plat of Subdivision for the Romeoville Towne Center Resubdivision

WHEREAS, Mid America Group has requested the approval of a Final Plat of Subdivision attached as Exhibit A and prepared by Gewalt Hamilton Associates; and,
